- 1. Call meeting to order, moment of silence and pledge of allegiance.
- 2. Roll call of the Supervisors.

# 3. Rheems Fire Department:

Representatives of the Rheems Fire Department will be in attendance to request a distribution of \$500,000.00 from the Mount Joy Township Capital Improvement Fund for the purchase of a 2026 Pierce Enforcer Engine to be disbursed during the 1<sup>st</sup> quarter of 2026.

# 4. 2843 Mount Pleasant Road – Rezoning:

- a. Open public hearing.
- b. Close public hearing.
- c. Discussion on and, if appropriate, a motion to enact an ordinance, whereby, upon enactment, Chapter 135, Zoning is amended to rezone land identified as 2843 Mount Pleasant Road from its present classification as Light Industrial District (LI) to Agricultural District (A). (Must be acted on within 60 days of the second advertisement which was Friday, November 5, 2025 60 days is January 2, 2026.)

Memorandum of Understanding Lancaster County Planning Commission: Authorize the Chairman of the Board of Supervisors to execute a Memorandum of Understanding between Mount Joy Township and the Lancaster County Planning Commission to refine and update the responsibilities of Mount Joy Township and the Lancaster County Planning Commission in regard to their roles in administering Subdivision and Land Development as discussed in Article V Section 501 and 502(b) of the MPC.
- d. <u>Engine Brake Retarder Ridge Road:</u> Authorize the Township Solicitor to prepare and advertise an ordinance to amend Chapter 127. Vehicles and Traffic, whereby Engine Brake Retarder

- Prohibition signs restricting use on Ridge Road, between the intersection of Ridgeview Road and Greentree Road are to be installed.
- e. <u>Bear Creek Estates</u>; 24-23-FLDP: Approve a reduction of Letter of Credit #2320020148, in its current amount of \$1,797,569.90 to \$930,435.90 as issued by Univest Bank & Trust to guarantee the proper installation of all improvements, excluding public sewer and public water facilities, for the Bear Creek Estates land development plan located along Sheaffer Road and E. College Avenue
- f. <u>Elmer Beiler (Christian Stoltzfus)</u>; 25-08-MLDP: Approve a reduction of Escrow in its current amount of \$55,146.10 to \$16,117.12 to guarantee the proper installation of all improvements, excluding public sewer and public water facilities, for the Beiler land development plan located 2980 Harvest Road.
- g. <u>Lancaster County Career & Technology Center</u>; 21-08-FLDP & 24-12-FSDP: Approve a reduction of Escrow, in its current amount of \$196,963.90 to \$41,547.15 to guarantee the proper installation of all improvements, excluding public sewer and public water facilities, for the LCCTC land development plan located along Old Market Street.
- h. <u>Lancaster County Career & Technology Center; FSDP-02-2016</u>: Approve a reduction of Escrow, in its current amount of \$45,889.60 to \$23,482.80 to guarantee the proper installation of all improvements, excluding public sewer and public water facilities, for the LCCTC land development plan located along Old Market Street.
- i. <u>Klein Mills (1376 Campus Rd) Phase 1A (SFD); 22-15-FLDP:</u> Approve a reduction of Letter of Credit #6000023009, in the amount of \$838,750.08 to \$769,110.57, as issued by PeoplesBank, a division of Orrstown Bank to guarantee the proper installation of all improvements, excluding public sewer and public water facilities, associated with the 1376 Campus Rd land development plan.
- j. <u>Klein Mills (1376 Campus Rd) Phase 1A (Shared); 22-15-FLDP:</u> Approve reduction of Letter of Credit #6000023066, in its current amount of \$246,441.04 to \$183,714.74, as issued by PeoplesBank, a division of Orrstown Bank to guarantee the proper installation of all improvements within the public right-of-way, excluding public sewer and public water facilities, for the 1376 Campus Road land development plan.
- k. <u>Featherton Crossing- Phase 4; 12-2017-FLDP:</u> Approve a release of Letter of Credit #STB891, in its current amount of \$116,408.00, as issued by Fulton Bank, for the 18-month maintenance guaranty for the dedication of a portion of Westbrooke Drive.
