1. Call meeting to order, moment of silence and pledge of allegiance.
2. Roll call of the Supervisors.
3. The Board of Supervisors held an Executive Session prior to tonight's meeting to discuss legal issues. Any official action to be taken based upon discussion held during the Executive Sessions will occur at an open public meeting.

 - b.  - c. Declaration of Snow Emergency: Approve, ratify and confirm the Township Managers execution of a Declaration of Snow Emergency whereby, pursuant to provisions of Section 7501 of the PA Emergency Management Services Code, (35 PA C.S. Section 7501, as amended), declared the existence of a snow emergency in Mount Joy Township on January 25, 2026.
 - d. Parks: Allow Middle Creek Search & Rescue and/or their individual members to use Township parks after closing hours for training purposes, as needed, contingent upon advising the Northwest Regional Lancaster County Police Department of the training dates and providing a Certificate of Liability.
 - e. Lancaster County Tax Claim Bureau: Authorize the Chairperson/Vice-Chairperson and the Township Secretary's execution of the Lancaster County Tax Claim Bureau of Certification of Uncollected Real Estate Taxes for 2025.

- f. Klein Mills (1376 Campus Rd) – Phase 1A (SFD); 22-15-FLDP: Approve a reduction of Letter of Credit #6000023009, in the amount of \$769,110.57 to \$674,895.31, as issued by PeoplesBank, a division of Orrstown Bank to guarantee the proper installation of all improvements, excluding public sewer and public water facilities, associated with the 1376 Campus Rd land development plan.
 - g. Klein Mills (1376 Campus Rd) – Phase 1A (Shared); 22-15-FLDP: Approve reduction of Letter of Credit #6000023066, in its current amount of \$183,714.74 to \$176,230.29, as issued by PeoplesBank, a division of Orrstown Bank to guarantee the proper installation of all improvements within the public right-of-way, excluding public sewer and public water facilities, for the 1376 Campus Road land development plan.
